- 1. Proposed Rule Filing, #3: Change Web URL to web address.
- 2. Proposed Rule Filing, #7: Clarify last paragraph.
- 3. Proposed Rule Filing, #8, first sentence: Remove the word 'a' prior to 'children's products'.
- 4. Proposed Rule Filing, #9, second sentence: 'children of chemicals with high concern' appears to be the title of the list however is not clear needs clarification.
- 5. Proposed Rule Filing, #12: Correct the word 'diminis'.
- 6. Proposed Rule Filing, #12, last sentence: remove the 's' from 'chemicals'.
- 7. Proposed Rule Filing, #16: Add 'Chemicals of high concern'.
- 8. Economic Impact Analysis, #3: Add language that refers to the original amendment.
