- Presentation of the following proposed rules:
 - 1. Health Care Administrative Rules Definitions, Agency of Human Services
 - a. This rule includes definitions for the Agency of Human Services' Health Care Administrative Rules (HCAR). This rule making amends the presently adopted HCAR rule on definitions, HCAR 1.101, by adding the definitions for durable medical equipment(DME) and Health Insurance Portability and Accountability Act (HIPAA).
 - 2. Home Health Agency Services, Agency of Human Services
 - a. The proposed rule sets forth the criteria for Medicaid coverage and reimbursement for Home Health Agency services under Vermont's Medicaid program. It revises and will replace current Medicaid covered services rule 7401 as part of the sequential adoption of Health Care Administrative Rules designed to improve public accessibility and comprehension of the numerous rules concerning the operation of Vermont's Medicaid program.
 - 3. Durable Medicaid Equipment, Agency of Human Services
 - a. The proposed rule sets forth the criteria for Medicaid coverage and reimbursement for durable medical equipment (DME) under Vermont's Medicaid program. It revises and will replace current Medicaid covered services rule 7505 as part of the sequential adoption of Health Care Administrative Rules designed to improve public accessibility and comprehension of the numerous rules concerning the operation of Vermont's Medicaid program.
 - 4. Wheelchairs, Mobility Devices, and Seating Systems, Agency of Human Services
 - a. The proposed rule sets forth the criteria for Medicaid coverage and reimbursement for wheelchairs, mobility devices, and seating systems covered under Vermont's Medicaid program. It revises and will replace current Medicaid Covered Services Rule 7506 as part of the sequential adoption of Health Care Administrative Rules designed to improve public accessibility and comprehension of the numerous rules concerning the operation of Vermont's Medicaid program.
 - 5. Telemonitoring Repeal, Agency of Human Services



- a. This proposed rulemaking is to repeal the Department of Vermont Health Access (DVHA) Rule 7702 titled "Telemonitoring" in its entirety. At the same time as filing this rulemaking, the Agency of Human Services (AHS) is filing a proposed rule titled "Telehealth Services" (3.101) which will set forth the criteria for telehealth services, including telemonitoring services, under Vermont's Medicaid program. It is a new rule to be adopted as part of the sequential adoption of Health Care Administrative Rules designed to improve public accessibility and comprehension of the numerous rules concerning the operation of Vermont's Medicaid program.
- 6. Telehealth, Agency of Human Services
 - a. The proposed rule sets forth the criteria for Medicaid coverage and reimbursement for Telehealth, including telemedicine, store and forward, and telemonitoring, under Vermont's Medicaid program. It is a new rule to be adopted as part of the sequential adoption of Health Care Administrative Rules designed to improve public accessibility and comprehension of the numerous rules concerning the operation of Vermont's Medicaid program.
- 7. Organization and Rules of Procedure, Department of Taxes
 - a. This rule updates the Organization and Rules of Procedure, last updated in 2012, Secretary of State Rule Log #12-019. It allows for certain filings online and notes changes to Department practice for filings in contested cases.
- 8. Vermont Sales and Use Tax Regulations, Department of Taxes
 - a. This rule updates Vermont's Sales and Use Tax Regulations, last updated in 2010 and includes updates to conform to changes in Title 32, Chapter 233, the Vermont Sales and Use Tax.
