## 2:24 p.m. **Proposed Rule: Health Benefit Eligibility and Enrollment Rule (HBEE) Parts 1-5, 7-8, Agency of Human Services**

Motion made to accept the rule by Diane Bothfeld, seconded by John Kessler, and passed unanimously except for Ashley Berliner who abstained with the following recommendations.

- 1. John suggested that a glossary of terms/acronym list be added to the Coversheet.
- 2. In part 10 of the Proposed Coversheet, John suggested the addition of the information that this rule will create a new pressure on the budget, and that half of the revenue is matched by the federal government. Diane suggested adding the economic impact to constituents, and Brad suggested adding the approximate number of people impacted.
- 3. Clare mentioned adding the Secretary of State log# to part 5 of the Adopting Page.
- 4. In Part 1, Section 4.02 (b), Clare suggesting putting "religion" back into the language, or adding a footnote indicating religious protection in another rule.
- 5. In Part 5, Section 29.08 (F) (I) (i) page 34, Diane suggests clarifying the language of this statement. John suggests separating the date and the explanation for clarity.
