INTERAGENCY COMMITTEE ON ADMINISTRATIVE RULES (ICAR) AGENDA Monday, July 9, 2018, 2:00 p.m. Pavilion 5th Floor Conference Room

- Presentation of the following proposed rules:
 - 1) Vermont Workers' Compensation and Occupational Disease Rules 1-27, Vermont Department of Labor
 - a. The proposed rules amend various definitions to conform with proposed changes to the Workers' Compensation Vocational Rehabilitation Rules.
 - b. Proposed Rule 3.1300 clarifies that the timeframe for reporting a "first aid only" claim is five business days.
 - c. Proposed Rule 7.1800 clarifies that an approved medical treatment preauthorization request expires if not acted upon within six months.
 - d. Proposed Rule 8.1200 changes the average weekly wage calculation to include (rather than exclude) paid leave time during the 26 weeks prior to the injury.
 - e. Proposed Rules 11.1400 and 12.1730 update the reference to the Vermont Department of Health's Rule Governing the Prescribing of Opioids for Pain.
 - f. Proposed Rule 20,1340 clarifies the manner in which attorney fee rates are increased as the Consumer Price Index increases.
 - 2) 3SquaresVT Rule Repeal, Agency of Human Services, Department of Children and Families
 - a. DCF proposes to repeal the current 3SquaresVT rule in its entirety.
 - 3) Stormwater Permitting Rule, Agency of Natural Resources
 - a. The Rule updates and combines all the stormwater rules, except the Vermont Stormwater Management Manual, in one comprehensive rule. The Rule includes the stormwater permitting requirements for all stormwater discharges the Agency must regulate pursuant to its authority to administer a permit program consistent with the federal National Pollutant Discharge Elimination System (NPDES); these include requirements for construction stormwater, municipal separate storm sewer systems (MS4s), industrial stormwater, and concentrated animal feeding operations (CAFOs). The Rule also includes stormwater permitting requirements unique to the State, which include



operational stormwater requirements for impervious surfaces of one or more acres, impervious surfaces of three or more acres, and municipal roads. To avoid duplicative permitting, the Rule has been drafted so that all permits issued under the Rule shall meet the minimum requirements of the Agency's authority to administer a program consistent with NPDES.
